### **Successful acquisition of Conditorei Coppenrath & Wiese – EU Commission approves merger**

#### **Independent activities and business strategy to remain intact**

**<Bielefeld, June 18, 2015> In a simplified procedure on June 17, 2015, the European Commission declared that the acquisition of Osnabrück-based confectioner Conditorei Coppenrath & Wiese GmbH & Co. KG by Dr. August Oetker KG was compatible with the internal market. This means that these merger plans have been approved unconditionally by the EU Commission. The shares in Conditorei Coppenrath & Wiese GmbH & Co. KG will be transferred effective June 30, 2015.**

The acquisition of Conditorei Coppenrath & Wiese allows Dr. Oetker to move into the market for frozen cakes, gateaux and bakery products, in which Coppenrath & Wiese has a leading position. The company produces exclusively in Germany and employs over 2,000 people at its bases in Mettingen and Osnabrück. Dr. Oetker has confirmed the employment guarantee agreed between the Coppenrath & Wiese works council and the company's previous owners last year. Both parties have agreed to maintain confidentiality regarding the exact selling price.

Richard Oetker, General Partner of Dr. August Oetker KG, commented as follows on the planned acquisition: "Good things always come to those who wait! We are delighted to welcome Coppenrath & Wiese to the Oetker family. This is a very special milestone in our company history and one that allows us to move into market segments in which we have not been active to date." Together, we want to continue the success story of Coppenrath & Wiese and to tap into further growth opportunities by targeting the international market to a greater extent. This means that Coppenrath & Wiese will come on board as an independent company within the Oetker Group."
